The total cost to provide these services is \$64,723.54 and UVMC/Premier Health Partners agrees to reimburse Miami County Department of Job and Family Services \$32,361.77, which is 50% of the cost to provide a staff member at the hospital, plus incur all IT expenses associated with said position. The remaining \$32,361.77 will be federally reimbursed to Miami County Department of Job and Family Services. The effective date of the MOU is July 1, 2022 through June 30, 2023. This new web-based program allows for a Kiosk so offenders can check-in, update personal information and self-report prior to meeting with their probation officer, the OCSS will also allow the officer to supervise remotely their offenders, removing any issues in transportation and employment conflicts. The requested grant amount is \$36,500.00, which covers document and data generation transfer from the current CourtView system, employee training, Go-Live with Kiosk and Court System set up.
