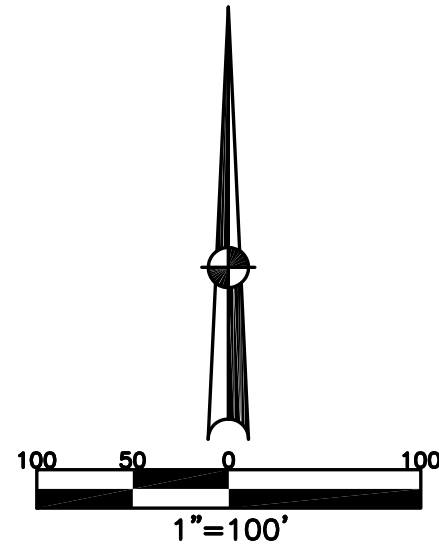

PART SOUTHEAST QUARTER



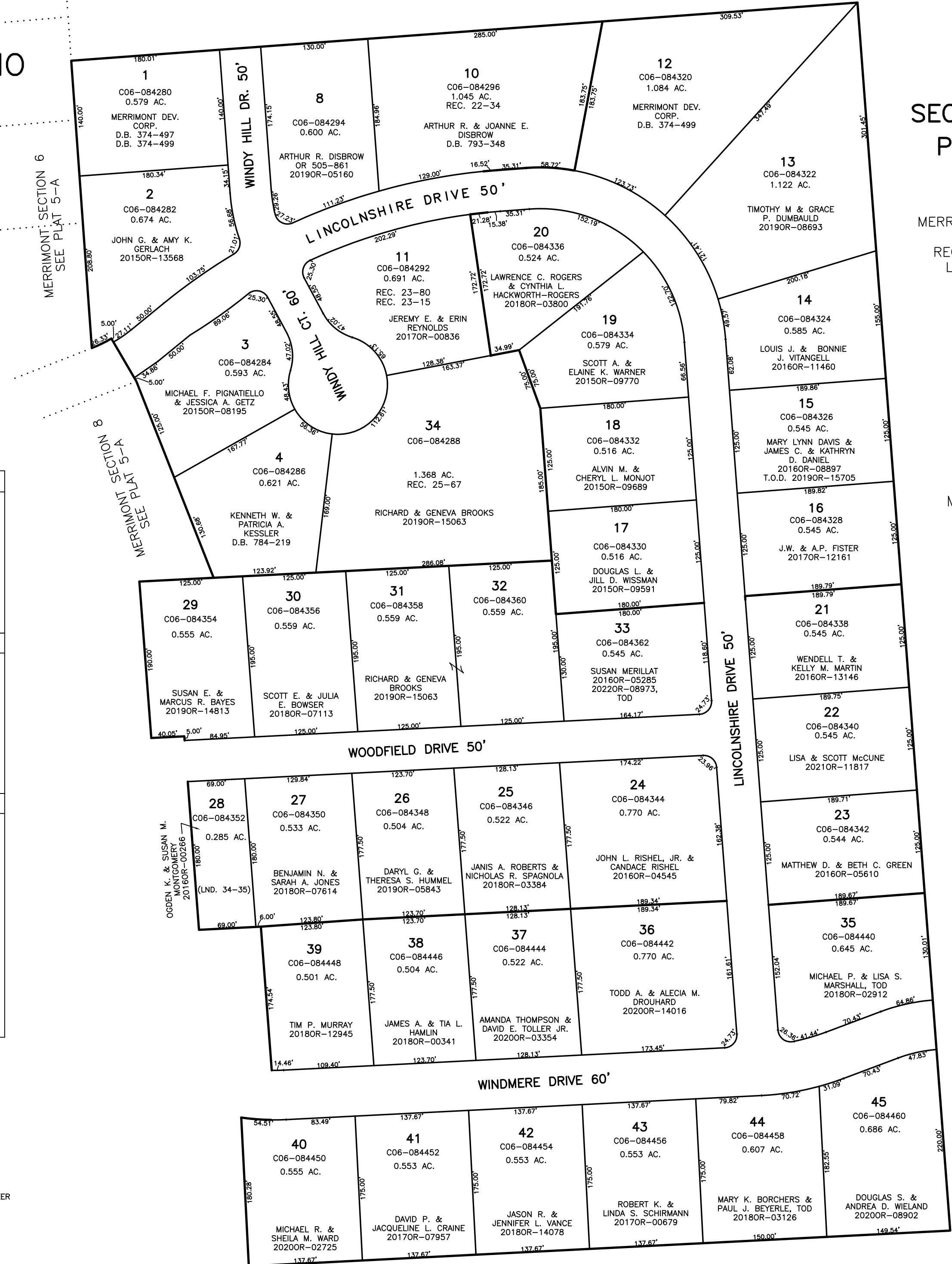
